The PCSP and PSNI have listened to the concerns of the community and acknowledge that the Text Alert Scheme is an important method of communication.

Not all citizens have access to or are comfortable with social networking platforms which many statutory, voluntary and community organisations now use to deliver key messages and information to their members.

The PCSP in conjunction with their colleagues in the PSNI have developed a Text Alert system which will allow them to communicate directly with citizens of Lisburn & Castlereagh City Council who sign up for the scheme by SMS text message almost instantaneously if there is an issue in their area.

What is Text Alert used for:

Members of Lisburn & Castlereagh Text Alert Scheme will receive an SMS message to their mobile phone with community safety information relevant to their area.

Text Alert can also be used to remind them of dangerous road conditions, suspicious vehicles, ongoing crime issues in the registered users particular area.
